#### **Administrative Matters**

#### Review & Approve Agenda

The agenda was reviewed and approved with no changes or amendments.

## Review and approve minutes of March 29, 2022, Trust Meeting

The minutes from the last meeting were reviewed and approved with no changes.

## **Debrief on Joint Trust meeting**

It was a good presentation to the St'at'imc Authority and several newer Chiefs were in attendance. There were some concerns discussed and there was acknowledgement that all were happy overall with the investment performance of the Trust and the good work of the Trustees.

There was a good discussion around how PCs request funds and the projected growth of the Legacy Fund with various percentage allocations of the annual funding.

#### **Status of Trust Funds**

A review of the Status of Trust Funds schedule to April 30, 2022, was provided noting that the Eleventh Anniversary Nation Annual Payment was received. It was noted that the funds held are more than the Minimum Protected Amount ("MPA").

The Trustees reviewed the Section 149(1)(c) reports memo and noted there is one community that still needs to submit its PCR for 2021.

#### Review and approve requests for payments and amendments from Beneficiaries

The Administrative Trustee indicated that there were requests for payments and an amending PCR for the Trustees consideration. All were reviewed and approved.

## Memo on distribution of the 2021 audited financial statements

The Trustees reviewed the memo on how the 2021 audited financial statements had been distributed at the end of March. There were no questions or concerns.

## **Annual General Meetings (AGM)**

## **Discuss considerations for AGMs**

The Trustees were provided with a memo highlighting the various considerations the Trustees would need to consider in planning for the AGMs.

A location was still trying to be confirmed for the Chilliwack meeting and that catering for both meetings was also still being confirmed.

The Trustees discussed door prizes for the September 7<sup>th</sup> & 8<sup>th</sup> AGMs and directed the Administrative Trustee to purchase the agreed upon items.

A discussion was held on COVID protocols and it was decided to provide hand sanitizer and masks, and to ask people to physically distance and not attend if they are feeling sick or have any COVID symptoms.

#### **Investing 101 Presentation**

The Trustees discussed having a presentation on investing basics to members before the AGM presentations. It was suggested that the presentation be held at 4:15 pm for a maximum of 45 minutes. The Administrative Trustee indicated that the AGM notices would also be updated to include notice of the presentation and related timing.

A draft of the AGM presentation was reviewed with the Trustees.
